Correctional Responses to Domestic Violence Victims. The scope of domestic violence perpetration in an offender population, regardless of the current crime of conviction. At least three behaviors that a domestic violence offender may use while incarcerated. At least one collaborative relationship/connection that could support a more proactive response to domestic violence.

A Proactive Response to Domestic Violence: Understanding ...

Victims' perceptions of how helpful police officers are in responding to domestic violence calls and victims' level of satisfaction are important issues to address. Many victims tend to view police officers who respond to their calls (or the calls of others) for assistance as being helpful (Robinson, 2000).
